APPLICATION FOR TRIAL MEMBERSHIP OF A SPORTING SECTION

The VRC welcomes individuals engaged in any sport associated with the Club or recognized by the HKSF & OC to apply for a Trial Membership of a Sporting Section. Applications are reviewed by the VRC Sub-Sports Committee and proposed to the General Committee for approval.

To apply for Trial Membership of a Sporting Section, the following criteria are considered and reviewed annually by the Sporting Committee:

- Demonstrated excellence in one of the Club's core sports.
- Willingness and ability to make voluntary contributions and serve the Club.
- Willingness and ability to support the Club in developing performance through coaching, mentoring, and participation in Sporting Section activities.
- Financial need or short-term presence in Hong Kong.

Trial Membership of a Sporting Section Guidelines:

- **Access to Club Facilities:** Trial members and their spouse/partner, on payment of the appropriate fee, can enjoy full access to all club facilities and are welcome to attend all club activities events at both VRC venues.
- **Training and Competition:** Trial members can participate in training sessions and compete or race for VRC.
- **Team Selection:** Trial members are treated equally in team selection processes.
- **Membership Card:** Trial members will receive a VRC Membership Card with an expiry date.
- **Membership conversion :** Trial members have the option to convert to Associate Membership after completing the required 80 support hours per year totalling 240 at the end of the 3-year term without additional entrance fee. Failure to reach the 240 support hours will result in the end of this contract.
- **Validity:**
 - Trial members are valid for three years.
 - Trial members are reviewed by the Sporting Committee and can be withdrawn at any time.
 - Trial membership can be terminated anytime by the member giving one month's notice.
 - Minimum age requirement is 16 years old.
- **Guest Access:** Trial members may bring guests, subject to guest fees similar to other VRC memberships.
- **Equipment Rental:** Trial members can rent club equipment.

- **Payment Method:** Prevailing monthly subscription fees must be paid via Direct Debit Authorization (DDA)

Trial Membership Restrictions:

- Trial members do not have voting rights and access to our reciprocal clubs.

Payment Terms:

- 30% of the entrance fee (at the time of application) of an Associate Membership in full, or two equal instalments over a period of the first 6 months
- VRC Club subscription fee in force at that time
- Fees set forth by the Sporting Section
- Board/boat storage fee (if provided)
- Subscription fee must be paid by DDA. Should the DDA stop working, membership will automatically be suspended until such time as the DDA is working.
