Articles of Association and By-Laws

Junior Membership Guidelines according to the Club's By-Laws (Part 7.10) and Article of Association (Part B - Membership No 5/h): Club's By-Laws (Part 7.10):

7.10 *Junior members:* Upon reaching the age of 18, and up to the age of 25, individuals may apply to become junior members, within an overall quota of 1,000. Junior members do not have voting rights but otherwise enjoy all the privileges and the benefits of membership, except boat storage. Junior members will be eligible to apply for the use of Club boats. Payment of the entrance fee may be made by instalments over 12-24 months. **Children of members may apply for Junior Membership at any age.**

Article of Association (Part B - Membership No 5/h):

h. Junior: A child of an applicant or Member, other than a Sporting Member, may apply for membership as a Junior Member at any time; and anyone between the age of 18 and 25 (which age range may be varied at the discretion of the Committee) may apply to be a Junior member. The number of Junior Members shall be limited to 1,000 at any time.
