Temporary Membership Guidelines and Benefits:

- **Spousal/Partner:** Temporary members can register their spouse/partner under their membership account.
- **Access to Club Facilities:** Temporary members and their spouse/partner can enjoy full access to all club facilities and are welcome to attend all club activities and events at both VRC venues.
- **Access to Reciprocal clubs:** Temporary members who are aged 18 years and above and their spouse/partner can enjoy access to the Club’s reciprocal clubs.
- **Training and Competition:** Temporary members can participate in training sessions and compete or race for VRC.
- **Team Selection:** Temporary members are treated equally in team selection processes.
- **Membership Card:** Temporary members will receive a VRC Membership Card with an expiry date.
- **Validity:** Temporary membership is valid for two years.
- **Guest Access:** Temporary members may bring guests, subject to guest fees similar to other VRC memberships.
- **Equipment Rental:** Temporary members can rent club equipment.
- **Boat Rack Rental :** Temporary members can rent a boat rack under discretion of the General Manager and subject to availability of space.
- **Payment Method:** monthly subscription fees must be paid via Direct Debit Authorization (DDA)

APPENDIX 1

The following changes to the terms and benefits of the 'Temporary Member of a Sporting Section' member category have been endorsed by the Club's General Committee and are subject to confirmation at the next General Meeting of the Club. Aside from the terms listed below, all existing terms and benefits for this category of membership remain unchanged.

1. Name: Temporary Member of a Sporting Section to be renamed: 'Sporting Member'.
2. Term: 3 years (from 2 years).
3. Commitment to team participation: requirement to complete a minimum of 70% of all training sessions. Sporting Members may not race for other teams or clubs.
4. Volunteering: requirement to volunteer in two areas: 1) as a race volunteer at a minimum of 5 race events (*see Note 1*) each year and 2) to support the growth of the club's youth development programme. Members will be required to log their hours and have these signed off by the Sporting Section and the Sporting Convener.
5. Conversion option: after 3 years, Sporting Members will have the option to convert to Associate membership with a joining fee equivalent to 30% of the Associate joining fee (fixed at the time of your becoming a Sporting Member). Conversion will be subject to completion of the training and volunteering requirements and will also be subject to approval by both the Sporting Committee and the General Committee.

Note 1: a race event is defined as one which is either planned and managed by the Club or endorsed by the Club.
